RONALD MCDONALD HOUSE CHARITIES OF SOUTHERN ARIZONA OWNS AND OPERATES A 28 BEDROOM HOUSE IN TUCSON, ARIZONA THAT PROVIDES TEMPORARY HOUSING FOR FAMILIES OF SERIOUSLY ILL CHILDREN WHO MUST LEAVE THEIR COMMUNITIES TO SEEK MEDICAL CARE FOR THEIR CHILDREN. THE HOUSE SERVES CHILDREN RECEIVING TREATMENT AT BANNER UNIVERSITY MEDICAL CENTER, TUCSON MEDICAL CENTER, CARONDELET ST. JOSEPH'S HOSPITAL, AND OTHER TREATMENT FACILITIES AND MEDICAL OFFICES IN THE TUCSON AREA. IN 2016 584 FAMILIES STAYED AT THE RONALD MCDONALD HOUSE FOR A TOTAL OF 4,519 "FAMILY NIGHTS".

FAMILIES OF SERIOUSLY ILL CHILDREN AGE 21 AND UNDER ARE ELIGIBLE TO STAY AT THE RONALD MCDONALD HOUSE. THEY MUST BE REFERRED TO THE HOUSE BY A SOCIAL

THE RONALD MCDONALD FAMILY ROOM AT BANNER CHILDREN'S DIAMOND CHILDREN'S MEDICAL CENTER IS AN EXTENSION OF THE SERVICES RONALD MCDONALD HOUSE OF SOUTHERN ARIZONA PROVIDES. THE FAMILY ROOM SERVES ALL PEDIATRIC IN-PATIENT FAMILIES AT THE CHILDREN'S MEDICAL CENTER. IT IS A SPECIAL PLACE WITHIN THE HOSPITAL, NEAR THE INTENSIVE CARE UNITS, WHERE FAMILIES CAN RELAX AND "GET AWAY" WHILE STILL BEING CLOSE TO THEIR CHILD. DURING 2016 WE SAW 7,794 VISITS TO THE FAMILY ROOM. FAMILY ROOM VOLUNTEERS STAFF THE ROOM, UPHOLD ALL FAMILY ROOM AND HOSPITAL POLICIES AND ARE SUPPORTIVE TO THE FAMILIES WHO USE THE ROOM. IN 2016 WE HAD 19 VOLUNTEERS WHO DONATED APPROXIMATELY 1,850 HOURS OF THEIR TIME.
