**RONALD MCDONALD HOUSE CHARITIES OF SOUTHERN ARIZONA OWNS AND OPERATES A 27-BEDROOM HOUSE IN TUCSON, ARIZONA THAT PROVIDES TEMPORARY HOUSING FOR FAMILIES OF SERIOUSLY ILL CHILDREN WHO MUST LEAVE THEIR COMMUNITIES TO SEEK MEDICAL CARE FOR THEIR CHILDREN. THE HOUSE SERVES FAMILIES OF CHILDREN RECEIVING TREATMENT AT BANNER UNIVERSITY MEDICAL CENTER, TUCSON MEDICAL CENTER, CARONDELET ST. JOSEPH'S HOSPITAL, AND OTHER CLINICS IN THE TUCSON AREA. IN 2018, 554 FAMILIES STAYED AT THE RONALD MCDONALD HOUSE FOR A TOTAL OF 5,141 "FAMILY NIGHTS".**

**THE RONALD MCDONALD FAMILY ROOM AT BANNER CHILDREN'S DIAMOND CHILDREN'S MEDICAL CENTER EXTENDS OF THE SERVICES RONALD MCDONALD HOUSE OF SOUTHERN ARIZONA PROVIDES. THE FAMILY ROOM SERVES ALL PEDIATRIC IN-PATIENT FAMILIES AT DIAMOND CHILDREN'S MEDICAL CENTER. IT IS A SPECIAL PLACE WITHIN THE HOSPITAL, NEAR THE NEONATAL INTENSIVE CARE UNIT, WHERE FAMILIES CAN RELAX AND REGROUP WHILE STILL BEING CLOSE TO THEIR CHILD. WE REMODELED THE FAMILY ROOM TO CREATE A MORE BEAUTIFUL, COMFORTABLE PLACE FOR FAMILIES. SINCE THEN THE NUMBER OF FAMILIES USING THE ROOM HAS DOUBLED.
