FAMILIES OF SERIOUSLY ILL CHILDREN WHO MUST LEAVE THEIR COMMUNITIES TO
SEEK MEDICAL CARE FOR THEIR CHILDREN. THE HOUSE SERVES FAMILIES OF
CHILDREN RECEIVING TREATMENT AT BANNER UNIVERSITY MEDICAL CENTER,
TUCSON MEDICAL CENTER, CARONDELET ST. JOSEPH'S HOSPITAL, AND OTHER
CLINICS IN THE TUCSON AREA. IN 2021, 332 FAMILIES STAYED AT THE RONALD
